

6. INR 90,000/- (Rupees Ninety Thousand only) per 9 sq.m. on shell scheme basis for Indian exhibitors or in proportion there of.
7. 10% extra for two side open booths.

8. Discount @ 10% on published tariff on raw space without carpet & with electrical point for island only.
9. Loyalty discount @ 10% extra would be given to those stall/island holders who have participated in **Expodent International India 2016** to the tune of area allotted in 2017
10. Service tax as applicable
