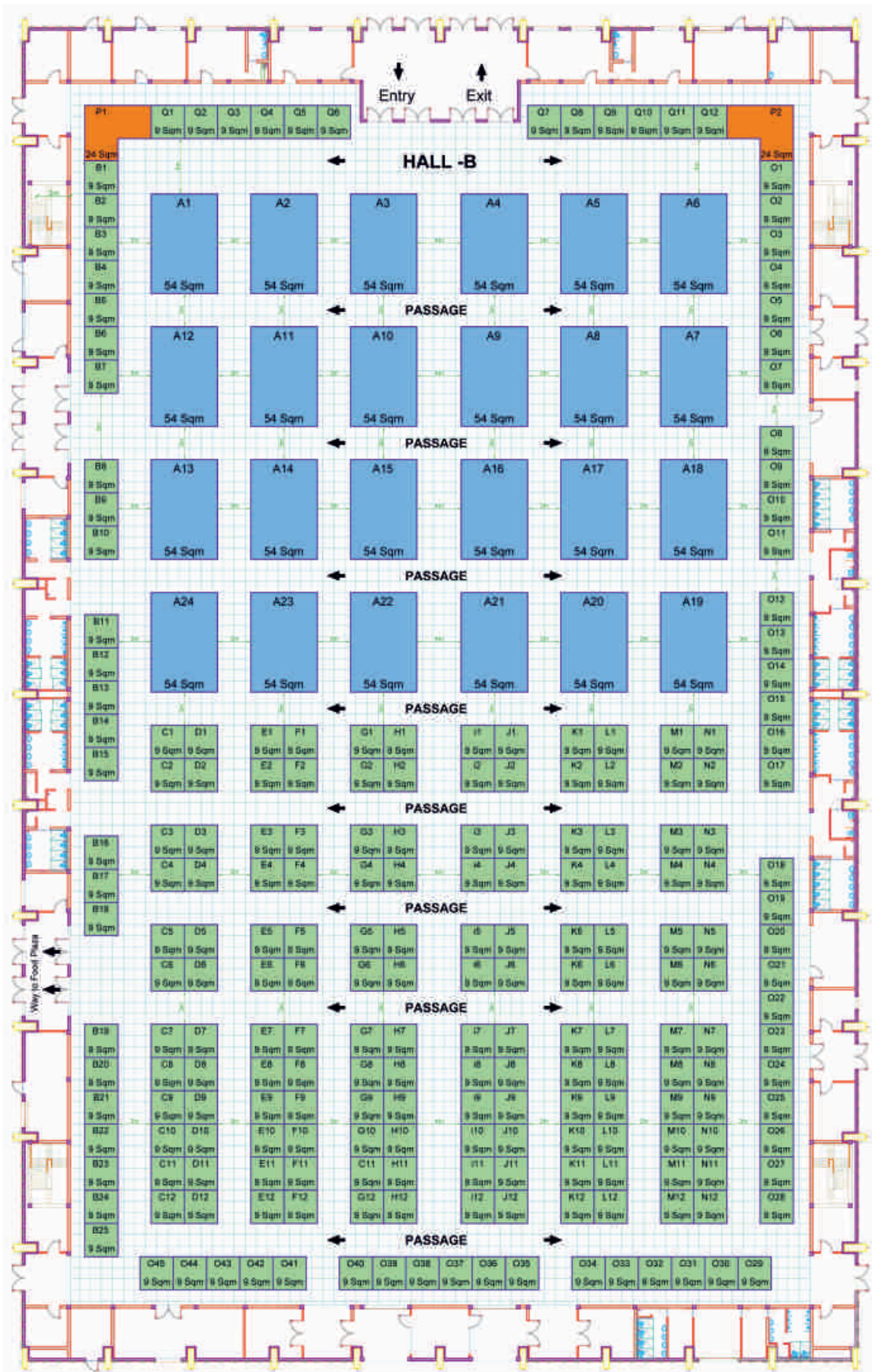

Exhibition Cum Sale Transactions Under GST :

For Company who does not have registration in Kolkata

You have to register as "Casual Taxable person (CTP)" which is compulsory. This registration you can do online from your place of business. Registration is not the responsibility of the organizers, it is totally your responsibility. All the information given below you have to abide by.

- All the Participants in an exhibition shall take registration in the state where the exhibition is held as a "Casual Taxable person (CTP)"
- Application for registration shall be made at least 5 days prior to commencement of exhibition.
- Security deposit of amount equivalent to estimated tax liability shall be given and the security deposit will be adjusted against tax liability.
- Registration is valid for 90 days.
- After obtaining the registration the CTP can transport the goods to exhibition venue by way of Tax invoice charging GST from his registered business place/factory.
- Every sale at the exhibition venue the CTP shall issue Tax invoice to customer and charge applicable GST
- The CTP has to file Monthly return as well as annual return for the registration obtained same time.
- After completion of exhibition any unsold stock can be taken back by raising invoice to his regular place of registered business place/ factory.
- Annual turnover limit of Rs. 20,00,000/- is not applicable to Casual taxable person.

REQUEST FOR CANCELLATION / REFUND

Cancellation of exhibition space should be made in writing to Expodent 2025 Kolkata not later than 25th Feb 2025 and the paid amount will be refunded if cancelled with valid reason. However the Committee reserves the right to final decision.
